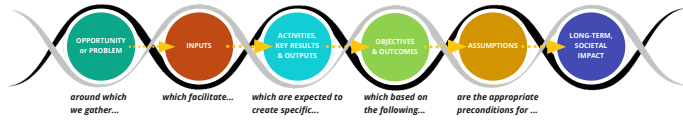

## Challenge

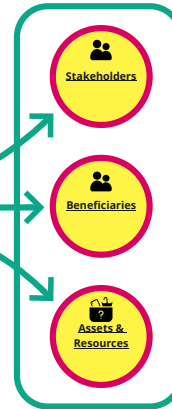

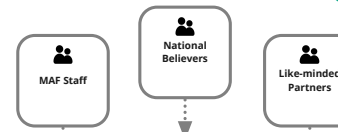

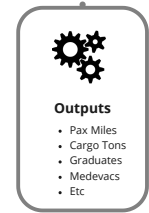


## Necessary Conditions
