Summary of Work, 2018-2019:

- 1. The WRC has increased participation of EPC women on Social media to 500 (Facebook and Blog).
- 2. The WRC has produced five videos that are available on Facebook, the EPC website, and The Well Blog.
- 3. The WRC has vetted Resources for women in the local church that are available at www.epc.org/thewell.
- 4. The WRC sent brochures, fliers, and a letter to EPC clerks of church Session to introduce the WRC to local churches, to solicit donations, and improve traffic on website, blog, and Facebook.

The Women's Resource Council (WRC) continues to support women in local churches to fulfill the mission and vision of the Evangelical Presbyterian Church. TE Sharon Beekmann conducted a seminar on Reformed Theology to equip Council members in the vetting of resources. WRC continues to recruit reviewers, writers, and editors for the ministry. The WRC planned five events for EPC General Assembly.
