Dear brothers and sisters,

It is a profound joy for me to be writing you this letter as it represents the possibility of deeper collaboration between the EPC and Reflejo. At Reflejo, we're passionate about being obedient to God as his body and working towards the expansion of his kingdom. For this reason, Reflejo was created as a missionary organization focused on recruiting, training, sending and supporting Latin American missionaries working to see gospel movements occur among people groups not yet reached by the gospel.

As you may know, this is no easy task as most "low hanging fruit" for the gospel has been harvested over the past two millennia. Thus, it is extremely important as the global church that we lock arms with brothers and sisters from different organizations and even nations to, in unity, fulfill God's great commission. It is with this desire that I write you since I think the EPC and Reflejo have complementing strengths and needs (specially surrounding our common commitment to reach Pashtuns for the Kingdom). We at Reflejo have willing candidates being equipped to go to the least reached, training resources and opportunities for churches, leaders and lay members to get involved in Kingdom work, and various connections into creative access locations across the globe. We also celebrate that the EPC has a large body of believers who faithfully pray for kingdom work, are actively seeking new ways to get involved in missions, as well as other resources, connections and training opportunities which will be a blessing to us. I'd like to once more take the opportunity to deeply express my excitement over this partnership.

Finally, since I believe there was a question regarding our ECFA accreditation, I'd like to further explain the nature of our organization. As Reflejo, we are not currently registered as a legal entity within the U.S. However, we have developed a tight-knit partnership with Novo Mission, a 501(c)3 in the U.S. who has opened the possibility for us to fiscally operate under their structure. This means that we raise, manage and spend funds coming from the U.S. all under the structure and protocols set forth by Novo. Novo maintains impeccable financial integrity and that is one of

the many reasons why we have chosen them as a partner in this regard. Due to this, they have received and maintain ECFA accreditation which extends to our operations as well.

Thank you for your consideration of this partnership, I pray a blessing over each one of you, your families and the denomination you shepherd.
