Important EPC Medical Benefit Information

- Starting January 1, 2022, the new EPC medical benefit administrator is Meritain Health. New ID Cards were mailed and if you have not received yours or if you find an error then call our EPC Administrative Office at 877-578-8707.
- You can log on and register your new Meritain Health account by clicking www.meritain.com. If you need assistance registering, click on the instructional flyer here.
- After registering you can see information about your benefits, claims, and have access to resources like Healthcare Bluebook, Nurse Health Coaches, Maternity Management, and the Provider Directory.

FREE COVID-19 TEST KITS

The federal government is providing 4 at-home COVID-19 rapid test kits FREE OF CHARGE to every U.S. household! Just click COVIDtests.gov or copy and paste <u>https://www.covidtests.gov/</u> into your browser. If you do not have internet access you can call 1-800-232-0233 to order kits. • Can I use an authorized at-home COVID-19 diagnostic test if it was left outside in freezing temperatures?

A. In order to ensure appropriate test performance with a test that is delivered to you in below freezing temperatures, you should bring the package inside your home and leave it unopened at room temperature for at least 2 hours before opening it. Once the package is at room temperature, you may open it and perform the test according to the authorized instructions for use.
