### Get Acquainted with Prescription Drug Terms

#### Prescription Order (Rx)

Written instruction for medicine that a licensed medical professional provides. The abbreviation for Prescription is Rx.

#### **Brand Name Drug**

A drug sold by a company under a specific name or trademark and is protected by a patent.

#### Generic Equivalent Drug

Same as the brand name drug in active ingredients, dosage, safety, strength, how it is taken, quality, performance, and intended use. It may have different inactive ingredients. Generally when a patent expires the generic version of the drug comes on the market. Before approving a generic drug product, the FDA requires many rigorous tests and procedures to assure that the generic drug can be substituted for the brand name drug.

#### Therapeutic Substitute

A drug with a different active ingredient than another brand name or generic drug, that is intended for use in treating the same clinical indications. Think of it like the three different approved COVID-19 vaccines. All designed to prevent the same disease but not using the exact same active ingredients.

## Drug Formulary (Express Scripts refers to their list as: National Preferred Formulary)

List of prescription drugs, both generic and brand name, that are preferred by your health plan that a committee of pharmacists and doctors has deemed to be the most effective and economical.

**Non-Formulary Drugs**Drugs not included on the preferred formulary list that have a preferred brand or generic substitute available. Usage of non-formulary medications may require a prior authorization and will be subject to higher co-pay levels even if pre-authorized.

#### Long-Term Maintenance Drugs (Medications)

Prescription drugs that are taken on a regular ongoing basis, such as drugs that treat high blood pressure, cholesterol, or chronic diseases.

#### Specialty Drugs (Medications)

Prescription drugs that require special handling, focused care, and monitoring. They are used to treat complex and chronic conditions like cancer, multiple sclerosis, and rheumatoid arthritis.



#### **DON'T ASSUME...**

all labs and diagnostic facilities are in-network, even if the facility is affiliated with an in-network doctor or clinic.

Obtaining lab work and diagnostic tests at an out-of-network facility will most often result in a balance billing that will cost you a lot of money. To find an in-network lab or facility contact the lab by phone or look them up on the **Find a Network Doctor** search tool here.

Fair Price is based on the typical fee that the hospital or other providers in a particular region accepts as payment from insurance companies.

#### Healthcare Blue Book even uses color codes:

√ Green	indicates price is at or below the Fair Price
<b>✓Yellow</b>	is slightly above the Fair Price
√Red	is the highest price
