## Great News for Younger EPC Retirement Plan Participants!

Planning to expand your family? Recently enacted Federal Regulations allow a distribution of up to \$5,000 to be taken for the Birth or Adoption of a child if authorized by the Plan.

To enable EPC Retirement Plan participants to take full advantage of this new provision we made the required amendment to the EPC Retirement Plan Document effective January 1, 2022. You can now take this withdrawal without a 10% early withdrawal penalty.

The rules states: "A distribution of up to \$5,000 for each child can be made with respect to multiple births and adoptions if the distribution is made within the 1-year period following the date on which the children are born, or the adoptions are finalized. An eligible adoptee is defined as any individual who has not attained age 18 or is physically or mentally incapable of self-support." There is also a provision that allows for recontribution of the distribution at a future date.

So, if you've had a birth or adoption within the past 12 months, even if it was before January 1st 2022 and would like to help offset those costs feel free to contact the EPC Benefits Office at <a href="mailto:benefits@epc.org">benefits@epc.org</a> for more information on the withdrawal process. Do keep in mind that you will still be responsible to pay any applicable income taxes. More information to come on this as the IRS issues further regulations.
