Be on the lookout for your new ID card!

If you are enrolled in an EPC medical benefit plan, be on the lookout any day now for your new insurance ID card from Meritain that will be effective January 1st. This card has information your doctor or pharmacist will need to submit your claims in 2024. It is very important to show to your pharmacist when ordering a prescription because it contains information about your new Prescription Drug administrator, BeneCard. Your old ID Card will not work for prescriptions in 2024.

Administration Corner - Retirement Contributions

- LAST CALL: Remember to submit all your 2023 contributions before the year end. We need to receive your submission by December 15th to be certain it will be credited for 2023.
- IN THE NEW YEAR: If you are using auto draft in SCP (Simplified Contribution Portal) for your employee retirement contributions, please remember to login to the $\,_{ extsf{O}}$ portal at the beginning of January 2024 and reset that auto draft to come out for the 2024 calendar year. This does not automatically occur!
